ARPA Local Fiscal Recover Funds

- Can be used for "necessary investments in water, sewer, or broadband infrastructure".
- Treasury Guidance: Use DWSRF/CWSRF eligibility
- Clean Water State Revolving Fund A Loan Fund.
- Loan eligibility is defined in the Clean Water Act.
- Allowed uses for CWSRF are very broad.



Traditional (and not so traditional) Clean Water Infrastructure

- Sewage Collection.
- Wastewater Treatment.
- Stormwater Collection and Treatment.
- Reclaimed Water (including Desalination).
- Grey Water.
- Biosolids treatment.
- Energy Efficiency or Water Conservation at any of these



Non Point Pollution

- Local efforts in support of:
 - State Nonpoint Pollution Plan
 - Puget Sound Action Agenda
 - Lower Columbia Estuary CCMP



Decentralized Wastewater Treatment Systems

- Septic System.
- Cluster Systems.
- Large Onsite Septic Systems.
- Watershed partnerships to prevent septic contamination.
- Establishment of Septic Management Entities.



Agricultural Best Management Practices

- Conservation Tillage.
- Stream Buffers.
- Stream Bank Stabilization.
- Water Efficient Irrigation Equipment.
- Water Efficient Irrigation Distribution.



Remediate or Prevent Contamination from Resource Extraction

- Acid Mine Drainage
- Fracking Discharge Wastewater
- Site Cleanup to Prevent Aquifer Contamination
- Prevent Runoff from Contaminated Sites
- Remove Contamination



Water Quality Impacts from Contaminated Sites

- Brownfield Sites
- Superfund Sites
- LUST (Leaking Underground Storage Tanks)



Water Quality Impacts from Landfills

• Projects to reduce, capture, treat, or reuse landfill leachate.



Water Quality Impacts from Silviculture

- Stream Revegetation.
- Erosion control on access roads.
- Revegetation of harvested sites.
- Purchase of Forested Lands to protect Water Quality.



Habitat Protection and Restoration

- Riparian Revegetation
- Wetland Restoration
- Swales / Filter Strips
- Fish Ladders
- Culvert Removal
- Prevent or Remove Invasive Species



Groundwater Protection and Restoration

- Pump and Treat projects
- Aquifer Recharge
- Projects to Reduce Aquifer Withdrawal.
